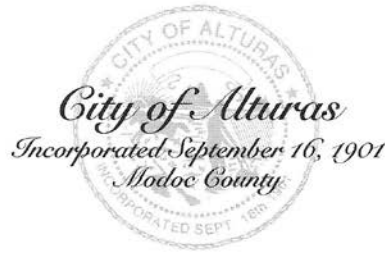

NOTICE OF TEMPORARY PROCEDURES FOR PLANNING COMMISSION MEETINGS
